


The Council of the Rural Municipality of Indian Head No. 156 in the Province of Saskatchewan, enacts as follows:





**WASTE TRANSFER STATION  
AGREEMENT**

BETWEEN

the TOWN OF INDIAN HEAD (the Town), a Municipal Corporation located in the Province of Saskatchewan

and

the RURAL MUNICIPALITY OF INDIAN HEAD NO. 156 (the RM), a Municipal Corporation located in the Province of Saskatchewan

WHEREAS the RM requires the service of a waste transfer station for use by residents in the RM;

AND WHEREAS the parties wish to enter into an agreement outlining the service to be provided and the compensation to be paid;

NOW THEREFORE THIS AGREEMENT WITNESSES that in consideration of the mutual agreement and conditions contained herein, the parties hereto agree as follows:

**1. SERVICES**

- 1.1 The Town will provide waste transfer station access to residents of the RM, RM residents are to follow the rules and regulations pertaining to the waste transfer station as described within the Towns Waste and Recycling Collection Management Bylaw, 6-2019.

**2. PAYMENT FOR SERVICE**

- 2.1 The RM is to pay the Town by January 31 of each of the next 20 years the fixed amount of \$3,064.00.
- 2.2 In addition to clause 2.1 the RM is to pay the Town by January 31 of each year a landfill management fee of \$2,000.00. This amount is to be reviewed by Town Council every two years and may be changed by resolution of Town Council. If Town Council passes a resolution to change the landfill management fee, 90 days' notice shall be given to the RM.
- 2.3 In addition to clause 2.1 and clause 2.2 the RM is to pay the Town by January 31 of each year an administration and miscellaneous maintenance fee of \$1,800.00. This amount is to be reviewed by Town Council every two years and may be changed by resolution of Town Council. If Town Council passes a resolution to change the administration and miscellaneous maintenance fee, 90 days' notice shall be given to the RM.


**3. TERMS OF AGREEMENT**


3.1 This agreement will remain in force from the day of its signing for perpetuity.





The Council of the Town of Indian Head in the Province of Saskatchewan, enacts as follows:



2. That the Mayor and Administrator of the Town of Indian Head are hereby authorized to sign the attached agreement identified as "Exhibit "A".





## WASTE TRANSFER STATION

### AGREEMENT

BETWEEN

the TOWN OF INDIAN HEAD (the Town), a Municipal Corporation located in the Province of Saskatchewan

and

the RURAL MUNICIPALITY OF INDIAN HEAD NO. 156 (the RM), a Municipal Corporation located in the Province of Saskatchewan

WHEREAS the RM requires the service of a waste transfer station for use by residents in the RM;

AND WHEREAS the parties wish to enter into an agreement outlining the service to be provided and the compensation to be paid;

- 2.3 In addition to clause 2.1 and clause 2.2 the RM is to pay the Town by January 31 of each year an administration and miscellaneous maintenance fee of \$1,800.00. This amount is to be reviewed by Town Council every two years and may be changed by resolution of Town Council. If Town Council passes a resolution to change the administration and miscellaneous maintenance fee, 90 days' notice shall be given to the RM.


3. TERMS OF AGREEMENT


