

The Council of the Rural Municipality of Indian Head No. 156 in the Province of Saskatchewan, enacts as follows:




RESORT VILLAGE OF THE DISTRICT OF KATEPWA

A BYLAW FOR THE RESORT VILLAGE OF THE DISTRICT OF KATEPWA IN THE PROVINCE OF SASKATCHEWAN TO PROVIDE FOR ENTERING INTO AN AGREEMENT WITH THE RURAL MUNICIPALITY OF INDIAN HEAD NO. 156 FOR THE PURPOSE OF PROVIDING GARBAGE COLLECTION SERVICES TO THE RURAL MUNICIPALITY.

GARBAGE COLLECTION AGREEMENT

BETWEEN

the **DISTRICT OF KATEPWA** (the District), a Municipal Corporation located in the Province of Saskatchewan

and

the **RURAL MUNICIPALITY OF INDIAN HEAD NO. 156** (the RM), a Municipal Corporation located in the Province of Saskatchewan

WHEREAS the RM requires the service of household residential garbage collection for residents living on Catherine Road in the residential subdivision.;

AND WHEREAS the parties wish to enter into an agreement outlining the service to be provided and the compensation to be paid;

NOW THEREFORE THIS AGREEMENT WITNESSES that in consideration of the mutual agreement and conditions contained herein, the parties hereto agree as follows:

1. SERVICES

1.1 The District will provide garbage collection weekly to residents of the RM. Living on Catherine Road; RM residents are to follow the rules and regulations pertaining to garbage collection as described within the Districts Garbage Policy 2012.

2. PAYMENT FOR SERVICE

2.1 The RM is to pay the District by January 31 of each year the fixed amount of \$2,000. This amount is to be reviewed by the District annually and may be changed by resolution of District Council. 90 days' notice shall be given to the RM should the fee be amended.


3. TERMS OF AGREEMENT

3.1 This agreement will remain in force from the day of its signing for perpetuity.


3.2 This agreement may be terminated by either party giving the other party 90 days written notice.






