
BYLAW NO. 215/2025


The Council of the RM of Indian Head in the Province of Saskatchewan, enacts as follows:

2. That the Reeve and Administrator of the RM of Indian Head are hereby authorized to sign the attached agreement identified as "Exhibit "A".








**ANNEXATION
AGREEMENT**

BETWEEN

the **TOWN OF INDIAN HEAD** (the Town), a Municipal Corporation located in the Province of Saskatchewan

and

the **RURAL MUNICIPALITY OF INDIAN HEAD NO. 156** (the RM), a Municipal Corporation located in the Province of Saskatchewan

WHEREAS the RM has lost municipal tax revenue due to the agreed upon annexation of certain lands by the Town;

AND WHEREAS the parties wish to enter into an agreement outlining the compensation to be paid for the annexation;

NOW THEREFORE THIS AGREEMENT WITNESSES that in consideration of the mutual agreements and conditions contained herein, the parties hereto agree as follows:

1. COMPENSATION

1.1 The Town agrees to compensate the RM in the amount of \$35,000.00 for the annexation of the following lands:

- a) BLK/Part T, Plan No. 101372521 Ext 13, Surface Parcel Number 121037510;
- b) Blk/Par Q, Plan 72R42001 Ext 0, Surface Parcel Number 110552891;
- c) NE 1/4 23-18-13-W2M Ext 1, Surface Parcel Number 203750434;
- d) Blk/Par B, Plan 102318757 Ext 0, Surface Parcel Number 203750423.

2. PAYMENT TERMS

2.1 The payment of \$35,000.00 shall be made in full to the RM after approval is given for the Municipal boundaries to be altered by the Minister of Government Relations, Community Planning Branch.


3. TERMS OF AGREEMENT

3.1 This agreement shall take effect upon the date of signing and shall remain in force until the obligations herein have been fulfilled.
