

**RM OF INDIAN HEAD NO. 156  
BYLAW NO. 217/25**


**A BYLAW OF THE RM OF INDIAN HEAD IN THE PROVINCE OF  
SASKATCHEWAN TO PROVIDE FOR ENTERING INTO AN AGREEMENT WITH  
THE TOWN INDIAN HEAD TO SHARE FUNDING OF MAINTENANCE PERSONNEL  
AT THE INDIAN HEAD CEMETERY.**

The Council of the Town of Indian Head in the Province of Saskatchewan enacts as follows:

1. The RM of Indian Head is hereby authorized to enter into an agreement, identified as Schedule "A", attached hereto and forming part of this bylaw, with the Town of Indian Head for the purpose of sharing funding of Maintenance Personnel for the Indian Head Cemetery.
2. The Reeve and Administrator of the RM of Indian Head are hereby authorized to sign and execute an agreement, the terms of which are set out in Schedule "A" attached hereto.
3. Bylaw No. 201/2023 is hereby repealed.

**SCHEDULE "A" TO BYLAW NO. 217/25**

This Agreement made the 11 day of June A.D., 2025

BETWEEN: The Town of Indian Head  
(hereinafter referred to as "the Town")  
a municipal corporation of and in the Province of  
Saskatchewan  
(Party of the First Part)

and Rural Municipality of Indian Head No. 156  
(hereinafter referred to as "R.M. 156")  
a municipal corporation of and in the Province of  
Saskatchewan  
(Party of the Second Part)

WHEREAS the parties hereto are desirous of entering into an agreement for joint funding of a Contractor to maintain the Indian Head Cemetery;

and

WHEREAS the Town and R. M. 156 will enter into an agreement with Raymond Ayers, the Contractor, to provide maintenance to the Indian Head Cemetery,

NOW THEREFORE THIS AGREEMENT WITNESSETH AS FOLLOWS:


1. The Town shall pay the Contractor responsible for maintaining the Indian Head Cemetery on the basis prescribed in the contract.
2. R. M. 156 shall reimburse the Town, fifty percent (50%) of the following described payments to the Contractor at the end of each month. 2025 shall consist of the following payments. \$2,250.00 at the end of May and the sum of \$4,500.00 at the end of June, July, August and September and the sum of \$2,250.00 on the 15<sup>th</sup> of October.
3. This agreement shall be binding on the Town and R. M. 156 through 2025. It may be extended or altered if the Contractor, the Town and R.M. 156 all agree on the option of continuing into 2026-2029.
4. A review of the Contractors rate is to be conducted after the first year (2025) is complete. If a change in rate is approved by the Town and R.M. 156, R.M. 156 shall reimburse the Town fifty percent (50%) of the mutually agreed upon adjusted rate.

**IN WITNESS WHEREOF** the RM has caused this Agreement to be executed under its Corporate Seal by the hand of its Reeve and Administrator and the Town has caused this Agreement to be executed under its Corporate Seal by the hand of its Mayor and Administrator, the day and year first above written.


