

BYLAW NO. 219-2025

A BYLAW FOR THE RURAL MUNICIPALITY OF INDIAN HEAD NO. 156 IN THE PROVINCE OF SASKATCHEWAN TO PROVIDE FOR ENTERING INTO AN AGREEMENT WITH THE DISTRICT OF KATEPWA FOR THE PURPOSE OF GARGAGE COLLECTION SERVICES PROVIDED BY KATEPWA.


The Council of the Rural Municipality of Indian Head No. 156 in the Province of Saskatchewan, enacts as follows:

1. The Rural Municipality of Indian Head No. 156 is hereby authorized to enter into an agreement, attached hereto and forming part of this bylaw, and identified as Exhibit "A" with the District of Katepwa, for the purposes stated within this agreement.



3. Bylaw 193-2021 is hereby repealed





GARBAGE COLLECTION AGREEMENT

BETWEEN

BETWEEN

the **DISTRICT OF KATEPWA** (The District), a Municipal Corporation located in the Province of Saskatchewan

and

the **RURAL MUNICIPALITY OF INDIAN HEAD NO. 156** (the RM), a Municipal Corporation located in the Province of Saskatchewan

WHEREAS the RM requires household residential garbage collection services for residents living on Catherine Road in the residential subdivision;

AND WHEREAS the parties wish to enter into an agreement outlining the services to be provided and the compensation to be paid;

NOW THERE THIS AGREEMENT WITNESSES t that in consideration of the mutual covenants and conditions contained herein, the parties agree as follows:

1. SERVICES

1.1 The District shall provide weekly garbage collection to residents of the RM living on Catherine Road. RM residents must adhere to the District’s Garbage Policy (2012), including all rules and regulations regarding collection.

2. PAYMENT OF SERVICE

2.1 The RM shall pay the district an annual fee of \$2,800.00, effective January 1, 2026.

2.2 Beginning January 1, 2027, and for each subsequent year, the annual fee shall automatically increase by three percent (3%), unless otherwise agreed in writing by both parties.

2.3 This schedule replaces and supersedes any previous fee schedules outlined in prior versions of this agreement.

3. TERMS OF AGREEMENT

3.1 This Agreement shall remain in force from the date of signing and shall continue in perpetuity unless terminated in accordance with clause 3.2.

3.2 This Agreement may be terminated by either party by providing ninety (90) days written notice to the other party.
