FIRE PROTECTION AGREEMENT – VILLAGE OF MCLEAN


A BYLAW FOR THE RURAL MUNICIPALITY OF INDIAN HEAD NO. 156 IN THE PROVINCE OF SASKATCHEWAN TO PROVIDE FOR ENTERING INTO AN AGREEMENT WITH THE TOWN OF INDIAN HEAD AND THE VILLAGE OF MCLEAN FOR FIRE PROTECTION SERVICES.

The Council of the Rural Municipality of Indian Head No. 156 in the Province of Saskatchewan, enacts as follows:


1. The Rural Municipality of Indian Head No. 156 is hereby authorized to enter into an agreement, attached hereto and forming part of this bylaw, and identified as Exhibit "A" with the Town of Indian Head, and the Village of McLean for the purposes stated within this agreement.

2. That the Reeve and Administrator of the Rural Municipality of Indian Head No. 156 are hereby authorized to sign and execute the attached agreement identified as Exhibit "A".





FIRE SERVICES AGREEMENT

This agreement made this 14 day of September, 2021

Between

THE TOWN OF INDIAN HEAD;
(Referred to as "the Town")
-and-
THE RURAL MUNICIPALITY OF INDIAN HEAD NO. 156
(Referred to as "the RM")
-and-
THE VILLAGE OF MCLEAN
(Referred to as "the Village")

WITNESSETH AS FOLLOWS:

- 1) The Town and RM hereby agrees to provide mutual aid fire suppression services to the Village.
- 2) It is understood and agreed by the parties involved, that the Town or RM are not liable for failure to respond to any fire calls or for damage to properties and persons involved in fire calls.
- 3) Fire calls made within the Village will be invoiced directly to the Village as follows:
 - a) Basic call-out fee: \$550 per hour per truck (for every hour from the time of the call)
 - b) Manpower charge: \$30.19 per person per hour to a maximum of 15 firefighters per call
 - c) All fuel and miscellaneous costs associated to the call will be billed at cost recovery.
- 4) In the event of inclement weather prevailing or poor road conditions existing, the Fire Chief or their designate may, in their sole discretion, decide not to dispatch any fire-fighting equipment, vehicles or fire-fighting personnel to a call for fire assistance; and, in such a situation, the Town and RM shall not be liable.
- 5) It is agreed that the parties will carry a minimum of \$2,000,000 (Two Million Dollars) liability insurance for fire suppression.
- 6) A call for assistance within the Town and RM of Indian Head shall always take priority over a call for assistance within the Village.
- 7) It is agreed that the Town and RM will bill directly to the Village of McLean for fire calls within the boundaries of the Village.
- 8) This agreement shall be continuous, but the agreement may be terminated by either the Town, RM or the Village of McLean by giving ninety (90) days written notice or be null and void immediately upon breach of agreement.
- 9) This agreement may be altered when both the Town, RM and the Village of McLean agree to make changes.
