## 2024 Taxes

The RM Taxes were levied and mailed on August 22. Please advise if you have not received a notice. There is a 4% discount on your municipal tax and hail insurance if paid no later than October 31, 2024; however, payment is not due until December 31, 2024. PLEASE NOTE, there is no discount on the school portion of the taxes.

Payment can be made via cash at the office, or cheque. The option to pay with credit card does exist with a 2% additional charge. There is the online option to set the RM us as a bill payment option at all RBC and Credit Union locations. Please use your account number if using that option.

## SNOW REMOVAL

As we head into winter, please take a minute to familiarize yourself with the RM's snow removal policy.

Piles of pushed snow left on or near the road can freeze into a solid mass creating a hazardous situation for vehicles and snowplows. It could also increase the chance of drifting on to the roadway.

This hazard on a municipal road expose those that use the road (residents, equipment operators etc.) to the risk of serious bodily injury and poses the risk of liability for the resulting damages to the party who pushed the snow on the road. Anyone who pushes snow on to a municipal road can also be liable for the costs for the R.M to remedy the damage done and can be fined under *The Highways and Transportation Act, 1997*.

The RM office accepts aluminum can tabs and continues to contribute them to Silver for Gold, a registered charity dedicated to raising funds and awareness to childhood cancer.
